

## **MONTANA USBC YOUTH HALL OF FAME**

1. The Montana USBC Youth Hall of Fame recognizes those individuals who have displayed outstanding ability in working with young people or have contributed meritorious service to the reputation and progress of the game in the area served by the Montana USBC Youth.
2. Membership in the Montana USBC Youth Hall of Fame shall be determined by annual nomination and selection.
3. Candidate qualifications:
  - (a) A candidate must have distinguished himself/herself by giving outstanding service to youth bowling in Montana.
  - (b) A candidate may qualify in one or more of the following areas:
    1. Coach
    2. Sponsor
    3. Friend of Bowling
    4. Association Secretary/Manager
    5. Proprietor
4. Guidelines for Submission:
  - (a) Completed nomination forms are to be submitted to the USBC Montana Hall of Fame Committee by March 1<sup>st</sup>.
5. Method of Selection:
  - (a) Complete nomination forms will be submitted to the MUSBC Hall of Fame Committee. The Hall of Fame Committee will review the applications, make recommendations.
  - (b) Recommendations will be presented to the MUSBC Board of Directors.
  - (c) Those selected will be inducted and honored at the spring Hall of Fame banquet. The inductee and one guest's meals will be paid for.
6. Suitable awards shall be made to those persons inducted into the Hall of Fame. In the case of Posthumous awards, they shall be presented to the nearest relative of the deceased.

If you or someone else is aware of how the person you are nominating for this award feels/felt about the work of volunteering with the youth in bowling and elsewhere, please take a few minutes to express this, and send it with the application.
